

## WHO ARE WE?

Founded 20 years ago in response to an emerging human rights crisis that has now reached a fever pitch under the current Administration, the Immigrant Defense Project (IDP) fights for justice and the human rights of immigrants in both the criminal and immigration systems.

## **HOW DID WE GET HERE?**

In 1996, Congress passed harsh immigration laws, rooted in the racialized and punitive tenets of the War on Crime: mass incarceration, unforgiving sentences, and deportation for a wide range of offenses.

The U.S. government now maintains the world's largest immigrant detention and deportation system. Permanent residents, people seeking refuge from persecution, and undocumented people with deep connections in the U.S. are all targets.

### WHY SUPPORT OUR WORK NOW?

The current administration has created a new war on immigrants, driven by fear, racism, hatred, and lies. IDP's strategies have evolved to fight back against this new wave of mass criminalization, detention, and deportation and continues to create change where it's needed most.

**COMMUNITY DEFENSE**: We support communities and grassroots groups with valuable resources, such as multilingual Know Your Rights trainings and materials, manuals on navigating these systems with cutting-edge legal arguments, and campaigns that have successfully kept José and Khalil (above), DREAMERs, and others back home with their families.

**STRATEGIC COMMUNICATIONS:** We counter the demonization of immigrants and people with criminal convictions and change the conversation by exposing the human toll of unjust policies.
