Dear New York City Council Members,

As immigrant rights organizations across New York City, we unequivocally condemn Mayor Adams' vetoes of the How Many Stops Act (Intro 586) and the Ban Solitary bill (Intro 549A), which shows blatant disregard for the safety and rights of Black, Latinx, immigrant and all New Yorkers impacted by discriminatory and abusive policing as well as the torturous practice of solitary confinement. We call on our City Council now to stand firm in their support for these bills.

The How Many Stops Act is a critical measure to shine light on the New York Police Department's daily activities and ensure comprehensive accounting of all street stops, investigative encounters and consent searches. We know that discriminatory policing practices often result in violence and - in all too many cases - [death of community members who interact with police](#). For immigrant New Yorkers, encounters with the NYPD can result in [finger-printing sharing with the FBI and ICE](#), and trigger ICE detention and deportation, [whether that person is ever charged with a crime or not](#). And any arrest, even where a case is dismissed, can be used as a negative factor resulting in deportation. We also know that while NYC has fought hard to put sanctuary policies in place, there continues to be [collusion between New York City and ICE](#), such that any arrest that results in DOC custody [further risks ICE detention and deportation](#).

The Ban Solitary bill is similarly long overdue legislation to end solitary confinement in New York City beyond four hours, a form of torture which has caused irreparable harm to countless people held in city custody. For immigrants in city jails, the psychological damage is often exacerbated by past experiences of persecution and trauma both in their countries of origin from which many have fled, as well as in [ICE detention facilities with egregious conditions that likewise subject people to prolonged solitary confinement](#). Additionally, immigrant New Yorkers in solitary confinement may face further challenges to communicating with loved ones abroad, unable to seek any support.

Both bills were passed by a supermajority of our Council, following years of advocacy by community members and their loved ones, whose lives have been irreversibly harmed by long-standing practices of our police and jails. Mayor Adams is on the wrong side of history, but the Council must not be. We call on every member of this Council to stand firm and override these vetoes.

To protect immigrant New Yorkers, and all New Yorkers, we call on you to vote yes to override Mayor Adams' vetoes of the How Many Stops Act and Ban Solitary bill.
