### **New York State Legislature Fails to Deliver Justice for Immigrants In the Face of Escalating Threats from Immigration and Customs Enforcement (ICE)**

**ALBANY, NEW YORK**-- The New York State legislature has failed to pass the [Protect Our Courts Act](#) to end ICE courthouse arrests, despite consensus by so many that this despicable practice must be stopped. As the Trump administration continues to threaten and inspire fear in immigrant communities, the legislature's inaction is unacceptable.

With broad support in the Senate and Assembly, New York was slated to become the first state in the nation to pass legislation limiting ICE enforcement operations at courthouses. Instead, the call from so many stakeholders--District Attorneys, former judges, and the 120+ organizations in the ICE Out of Courts Coalition--went unanswered. The bill was under consideration until the last day of the legislative session.

In April, as a result of the ICE Out of Courts Coalition's advocacy, the New York State Office of Court Administration issued a directive prohibiting ICE arrests in courthouses without a judicial warrant. The Protect Our Courts Act would have codified these rules and added protections for people arrested attending and leaving courthouses, where ICE operations are most active.

The Immigrant Defense Project (IDP) has documented a 1700% increase in ICE courthouse arrest activity since the Trump administration took office in 2017. IDP has tracked ICE's increasingly aggressive tactics, including assaulting immigrants and their attorneys, and ripping people away from both court proceedings and their loved ones while pretending to be local police.

Our organizations came together to push New York State to act immediately to halt ICE arrests. Although the bill did not pass today, as ICE and the Trump administration continues to threaten and terrorize our communities, we will continue to fight for passage on the first day of the legislative session next year.

“ICE’s practice of exploiting the New York court system to harm our communities and further its mission of surveilling, arresting, detaining, and deporting New Yorkers is well-documented and ongoing. Just this week, while New York legislators were in session and considering passing the Protect Our Courts Act, we received reports of multiple ICE arrests at courthouses in Queens. Despite a broad consensus that this legislation was essential in protecting both New York’s courts and New Yorkers themselves, legislators were unable to act. ICE is unrelenting and we need leadership at the state and local levels to step up and protect our communities. “Access to equal justice was once again deferred for immigrant New Yorkers. Survivors deterred from testifying against abusers. ICE stalking our courthouses and detaining people before proven guilty. Our communities and movements will not wait. "Under the Trump Administration, we are experiencing the harshest and most broad-sweeping immigration enforcement regime in modern history, as well as an unprecedented undermining of due process in immigration courts. While OCA's protocol is a significant step in the direction of protecting immigrant New Yorkers from the aggressive ICE enforcement at courthouses, our clients still face serious hurdles to having a fair day in court, as there is still a high risk of ICE arrests as they travel to and from court appearances or enter and exit court buildings. Some are witnesses in criminal cases against their abusers. ICE in our courthouses and the threat of detention and deportation spreads fear, not justice, and deters many of our clients from seeking the protections that are rightfully theirs. We applaud the Chief Judge's decision to require judicial warrants or judicial orders for ICE arrests in New York State courthouses and call on the Legislature to enact this vital legislation in the next session." **Hon.
